Chapter Activities

In particular, the activities in our chapters contribute concretely to 3 focus areas in which the EACC is leading for its members:

Stimulate business development opportunities.

- Providing warm one-to-one introductions by our local chapter heads to members who seek in Europe or the U.S. clients, business partners, investors, M&A candidates, etc.
- Coordinate (and follow up on) direct referrals from members who are searching specific professionals or organizations to grow their business.

Currently Topical EACC-wide
